**THE BANKING (AMENDMENT) ACT, 2015**

**No. 16 of 2015**

**AN ACT** to amend the Banking Act, 2015.

**ENACTED** by the Parliament of Antigua and Barbuda as follows:

**1. Short title**

This Act may be cited as the Banking (Amendment) Act, 2015.

**2. Interpretation**

In this Act—

“principal Act” means the Banking Act, 2015

**3. Amendment of section 153**

The principal Act is amended in section 153 as follows—

(a) by inserting after paragraph (a) of subsection (2) thereof the following new paragraph—

“(b) severance payments;”;

- (b) by repealing the words “severance payments” before the word “wages” in paragraph (b);
- (c) by renumbering paragraph “(b)” as paragraph “(c)” and all other subsequent paragraphs to be renumbered in consecutive alphabetical order as follows—

paragraph “(c)” becomes paragraph “(d)”, paragraph “(d)” becomes paragraph “(e)”, paragraph “(e)” becomes paragraph “(f)”, paragraph “(f)” becomes paragraph “(g)”, paragraph “(g)” becomes paragraph “(h)”, paragraph “(h)” becomes paragraph “(i)”, paragraph “(i)” becomes paragraph “(j)” and “(j)” becomes paragraph “(k)”;

- (d) by repealing the letter “(e)” in paragraph “(c)” and substituting the letter “(f)”;
- (e) by repealing the letters “(c)” and “(e)” in paragraph “(d)” and substituting therefor the letters “(d)” and “(f)” respectively.
- (f) in subsection (7), by repealing the letters “(c), (d) and (e)” and substituting therefor the letters “(d), (e) and (f)” respectively.
