**ANTIGUA AND BARBUDA**

**No. 17 of 2004**

AN ACT to amend the Bills of Sale Act, Cap. 51.

*[Published in the Official Gazette Vol. XXIV No. 79  
dated the 4th November, 2004 ]*

**ENACTED** by the Parliament of Antigua and Barbuda as follows:

1. This Act may be cited as the Bills of Sale (Amendment) Act, 2004. Short title.

2. The Bills of Sale Act, in this Act referred to as "the principal Act," is amended by inserting after subsection 8(3) the following — Amendment of section 8.

"(4) The Registrar shall within one month of its registration forward to the General Manager of the Transport Board a certified copy of every Bill of Sale and every Memorandum of Satisfaction registered under this Act in respect of a motor vehicle for the purpose of entering on the Transport Board's records the particulars of the Bill of Sale and the subsequent Memorandum of Satisfaction in respect of such motor vehicle."

3. Section 13 of the principal Act is repealed and substituted by the following —

“(1) The Registrar shall order a Memorandum of Satisfaction to be filed and shall note the particulars thereof upon every registered copy of a Bill of Sale;

“(2) Every Memorandum of Satisfaction shall be registered under this Act in the manner prescribed by the Registrar and a certified copy thereof shall be forwarded to the General Manager of the Transport Board.

4. Section 14 of the principal Act is amended by deleting the words "twenty-four cents" and substituting the words "ten dollars".

Amendment of  
section 16.

5. Section 16 of the principal Act is repealed and the following substituted —

"16. There shall be paid to the Registrar in stamps the following fees —
