AN ACT to amend the Evidence Act, Cap. 155 and for incidental and connected purposes.

ENACTED by the Parliament of Antigua and Barbuda as follows:

1. Short title

This Act may be cited as the Evidence (Amendment) Act, 2012.

2. Interpretation

In this Act—

"principal Act" means the Evidence Act, Cap. 155;

"Director of the ONDCP" means the person holding the position of Director under section 3 of the ONDCP Act 2003;

"ONDCP Manager" means an officer of the ONDCP who holds the rank of manager or higher rank within that organisation;

"ONDCP" means the Office of National Drug and Money Laundering Control Policy established pursuant to the ONDCP Act 2003, No. 11 of 2003.
