AN ACT to amend the Immigration and Passport Act, 2014 No. 6 of 2014 and for incidental and connected purposes.

ENACTED by the Parliament of Antigua and Barbuda as follows:

1. Short title

This Act may be cited as the Immigration and Passport (Amendment) Act, 2016.

2. Interpretation

(1) In this Act "the principal Act" means the Immigration and Passport Act 2014, No. 6 of 2014.
