JOSEPH HUNTE (PENSION) ACT 2013 No. 15 of 2013

AN ACT to make provision for the grant of Pension to Joseph Hunte under the Pension Act Cap. 311, as amended.

ENACTED by the Parliament of Antigua and Barbuda as follows:

1. Short title

This Act may be cited as Joseph Hunte (Pension) Act 2013.

2. Authority to reckon Pensionable Service

- (1) Notwithstanding anything to the contrary in the Pension Act, Cap. 311 and the Pension Regulations, as amended, it shall be lawful to reckon the service of Joseph Hunte during his employment as
 - (a) a civil servant for the period commencing on 1st May, 1967 and terminating on 1st March 1974;
 - (b) an employee of the Public Utilities Authority for the period commencing on 1st March 1974 until 10th September 2008 when he attained the retiring age of 60 years.

(2) The period specified in subsection (1) and the offices held by Joseph Hunte during the specified period shall be reckoned as service in a pensionable office of the Government for the purpose of computing the pension that may be granted to him under the Pension Act, Cap. 311.

3. Authority to pay pension out of the Consolidate Fund

Authority is hereby granted to pay out of the Consolidated Fund, the pension computed for Joseph Hunte under Section 4.

4. Application of the Pension Act, Cap. 311

- (1) Subject to subsection (2), the provisions of the Pension Act, Cap.311 and any regulations made thereunder shall apply to the computation of the pension of Joseph Hunte.
- (2) For the purpose of computing the pension or alternatively the gratuity and reduced pension that may be granted to Joseph Hunte, account shall be taken of the retirement benefits already paid to him by the Public Utilities Authority.
