# LICENSING (INTOXICATING LIQUOR) (AMENDMENT) ACT, 2014 No. 9 of 2014

**ANACT** to amend the Licensing (Intoxicating Liquor) Act, Cap. 249.

**ENACTED** by the Parliament of Antigua and Barbuda as follows:

#### 1. Short title

This Act may be cited as the Licensing (Intoxicating Liquor) (Amendment) Act, 2014.

#### 2. Amendment of section 32 – Hours of closing

Section 32 of the Licensing (Intoxicating Liquor) Act, Cap. 249 is amended as follows —

- (a) by the repeal of subsection (1) and the substitution of the following
  - (1) Subject as hereinafter provided all licensed premises on which intoxicating liquor are sold, exposed or kept for sale by retail except those premises in respect of which hotel license, a tavern licence or club licence has been granted, shall be closed to the public during the whole of Good Friday.
