- 1. This Act may be cited as the Land Settlement and Short title. Development Board (Repeal) Act.
 - 2. In this Act—

Interpretation.

"Board" means the Board established under the provisions of section 3 of the Land Settlement and Development Board Act, 1946;

- "Fund" means the Fund established under the provisions of section 11 of the Land Settlement and Development Board Act, 1946.
- 3. All lands which, immediately prior to the coming Disposal of lands of the Board. into force of this Act, were owned in fee simple by the Board shall be deemed, on such coming into force, to have been surrendered to and to have vested absolutely in the Crown.

All moveable property of the Board to which the Moveable Cabinet may direct that this section shall apply shall be **Board**. deemed, on the coming into force of this Act, to have been transferred to, and to have become the property of, the Government.

The benefit and burden of all leases and tenancy Leases and agreements in which the Board was tenant, immediately prior agreements. to the coming into force of this Act, shall be deemed, on such coming into force, to have been transferred from the Board to the Government.

Contracts.

6. The benefit and the burden of any contract made by the Board and in force immediately prior to the coming into force of this Act, being a contract to which the Cabinet may direct that this section shall apply, shall, on such coming into force, be deemed to have been transferred from the Board to the Government.

Liabilities.

7. The Cabinet may direct that any liability of the Board shall be deemed to have been transferred to, and become the liability of, the Government.

General power to make orders for disposal of the Fund and transfer of the undertaking.

- **8.** The Cabinet may by order make such provision as may appear to them expedient—
 - (a) for disposal of any sums remaining in the Fund at the commencement of this Act; and
 - (b) for securing the transfer to the Government of the undertaking, or any part thereof, of the Board and for matters consequential thereon.
