MOTOR VEHICLES (CONTROL OF HIRE)

- ${f 1.}$ This Act may be cited as the Motor Vehicles Short title. (Control of Hire) Act.
 - 2. In this Act—

Interpretation.

- "motor car" means a motor vehicle, other than a motor lorry the weight of which unladen exceeds three thousand six hundred pounds;
- "motor lorry" means a motor vehicle constructed or adapted for the use of and used primarily for the conveyance or haulage of goods, merchandise or other loads;

- "motor vehicle" means any mechanically propelled vehicle intended or adapted for use on roads;
- "the Minister" means the Minister of Government for the time being charged with the responsibility for the subject of Public Utilities.

Permits to hire required.

- **3.** (1) Notwithstanding anything to the contrary contained in the Vehicles and Road Traffic Act, as amended, or in any regulations made thereunder, no person shall—
 - (a) hire a motor car to any other person, or
 - (b) permit his motor car to be hired to any other person, or
- (c) carry any other person in his motor car in consideration of a sum of money or other reward, or for the purpose of obtaining thereby some pecuniary benefit, except under and in accordance with the terms of a permit issued for the purpose by the Minister.
- (2) Any person desiring to obtain the issue to him of a permit as aforementioned shall make application, in duplicate, to the Minister through the Commissioner of Police who shall forward the original application to the Minister. The Minister on receipt of the application may either refuse to issue a permit, or may issue or cause to be issued on his behalf a permit, subject to such conditions as may be prescribed by regulations made under this Act, and to such further conditions as he may deem fit and proper to have endorsed thereon. Any person aggrieved, by the refusal of the Minister to grant him a permit, or by any condition endorsed on his permit, may, within fourteen days after he is notified in writing of such refusal, appeal to the Cabinet, and the decision of the Cabinet in the matter shall be final and shall not be questioned in any legal proceeding.
- (3) Every permit issued under the provisions of this Act shall expire on the 31st day of December of the year in which it was issued.
- (4) Until other forms are prescribed by regulations made under the provisions of this Act, the form of application for a permit shall be as set out in Form A of the Schedule, and

the form of permit shall be as set out in Form B of the Schedule.

- (5) Any person who, after the 15th day of January, 1962—
 - (a) hires a motor car to another person, or
 - (b) permits his motor car to be hired to another person, or
 - (c) uses his motor car,

in contravention of the provisions of subsection (1) or in contravention of any of the conditions of a permit issued under this section shall be guilty of an offence against this Act.

- 4. (1) The Cabinet may make regulations pre-Regulations. scribing—
 - (a) the form of permits, or application for a permit, to be used under this Act,
 - (b) the fees to be charged for the issue of such permits,
 - (c) the conditions under and subject to which such permits may be issued.
- (2) Regulations made under this Act may provide for the imposition of penalties, not exceeding one thousand dollars, for any breach of the provisions of the said regulations.
- **5.** Any person who wilfully gives any false information. Giving of false tion in his application for a permit shall be guilty of an offence against this Act.
- **6.** Any person found guilty of an offence against this Penalty. Act shall be liable on summary conviction to a fine not exceeding three thousand dollars, and in addition thereto in respect of a continuing offence to a fine not exceeding two hundred and fifty dollars in respect of each day during which such an offence is continued.
