BUSINESS NAMES (AMENDMENT OF FEES) ORDER, 2020 made by the Minister in exercise of the powers contained in section 19(3) of the Business Names Act Cap. 63.

1. Citation

This Order may be cited as the Business Names (Amendment of Fees) Order, 2020.

2. Amendment to Second Schedule

The Minister responsible for Finance, in exercise of the powers contained in section 19(3) of the Business Names Act has amended the second schedule of the Business Names Act by prescribing the following new fees –
