**THE CUSTOMS (CONTROL AND MANAGEMENT) (PANDEMIC RELIEF BARREL)
(EXEMPTION) ORDER made in exercise of the powers contained in section 71, of the
Customs (Control and Management) Act, 2013 Act No. 3 of 2013.**

1. Short title

This Order may be cited as the Customs (Control and Management) (Pandemic Relief Barrel) (Exemption) Order, 2020.

2. Exemption from duties

(1) The Christmas Barrel Initiative shall apply to an individual who imports a barrel for personal use into Antigua and Barbuda between 1st April, 2020 and 30th June, 2020.

(2) One or more of the following items, not being merchandise for sale and being for personal use, imported by an individual between 1st April, 2020 and 30th June, 2020 are hereby exempt from duty—

(3) The exemption granted under subsection (2) is limited to a maximum of one standard size shipping barrel or E-Container (equivalent to a standard size shipping barrel) with dimensions: 17.97 cubic feet (42"x 29"x 25.5"); for each household and shall not apply where the barrel also contains any items other than those specified in subsection (2).

(4) For the purpose of these Regulations, the Antigua and Barbuda Sales Tax Act, 2006, No. 5 of 2006, as amended by the Antigua and Barbuda Sales Tax (Amendment) Act, 2008, No. 2 of 2008, shall be applied to the Pandemic Relief Barrel in the same manner as it applies to the Dollar Barrel Initiative.

3. Simplified Customs Declaration Form

The Form prescribed in the Schedule is the Form to be completed in respect of any items that are to be exempt pursuant to section 2 of this Order.

4. Commencement

This Order comes into force on the 1st April, 2020
