THE Customs Duties Act (Amendment of Schedule) (No. 2) ORDER made in exercise of the powers contained in section 5 of the Customs Duties Act, 1993 (No. 27 of 1993).

1. Short title and Commencement

This Order may be cited as the Customs Duties Act (Amendment of Schedule) (No. 2) Order, 2020, and shall come into force on the 1st January, 2020.

2. Amendment of Schedule.

The First Schedule to the Customs Duties Act, No. 27 of 1993 is hereby amended by replacing the figures stated under the column entitled "Rate of Duty", as they apply to the following list of "Heading Nos." of The Tariff, with the figures appearing on the right of the said list of "Heading Nos.":
