made in exercise of the powers contained in section 5 of the Customs Duties Act, 1993 (No. 27 of 1993).

**1. Short title and Commencement**

This Order may be cited as the Customs Duties Act (Amendment of Schedule) Order, 2008, and shall come into force on the 14th April, 2008.

**2. Amendment of Schedule.**
