THE CUSTOMS (DUTY FREE SHOPPING) (DECLARATION OF APPROVED PREMISES) ORDER made in exercise of the powers contained in section 3 of the Customs (Duty Free Shopping) Act, Cap 127.

Short title

This Order may be cited as the Customs (Duty Free Shopping) (Declaration of Approved Premises) Order, 2015.

2. Declaration of Approved Premises

- (1) The following Hotels and or Resorts listed in the Schedule are declared as Approved Premises for the purpose of establishing duty-free boutiques, jewellery shops and other souvenir shops that the Comptroller may approve from time to time.
- (2) In the event permanent duty-free shops are not to be established in the hotels and resorts listed in the Schedule, the practice of temporary removal of jewellery and other items from dutyfree Stores in Heritage Quay, Redcliffe Quay and the V.C. Bird International Airport for display purposes at any of the above mentioned hotels and resorts will continue under the prior approval of the Comptroller of Customs.
- (3) The existing licensing procedures will apply for the new duty-free shops to be established in the listed Approved Premises.
