**THE CUSTOMS (PRESCRIPTION OF DECLARATION FOR ENTRY BY BILL OF SIGHT FORM) REGULATIONS, 2008 made by the Comptroller of Customs under section 26 of the Customs Control and Management Act, No. 7 of 1993.**

**1. Short title**

These Regulations may be cited as The Customs (Prescription of Declaration for Entry by Bill of Sight Form ) Regulations, 2008.

**2. Declaration of Entry by Bill of Sight Form**

The form prescribed in the Schedule is the Form to be completed in respect of a declaration made under section 27 of the Customs Control and Management Act, No. 7 of 1993.

**3. Commencement**

These regulations come into force on the 30th day of June, 2008.




