**DECLARATION dated the 15th of DECEMBER 2015, made by the SECRETARY TO THE CABINET UNDER SECTION 3 OF THE LAND ACQUISITION ACT CAP 233 FOR THE ACQUISITION OF THE PARCEL OF LAND DESCRIBED IN THE SCHEDULE FOR A PUBLIC PURPOSE.**

**WHEREAS** it is provided in Section 3 of the Land Acquisition Act Cap. 233 that “if the Cabinet considers that any land should be acquired for a public purpose they may, with the approval of the Legislature, cause a declaration to that effect to be made by the Secretary to the Cabinet in the manner provided by this section and the declaration shall be conclusive evidence that the land to which it relates is required for a public purpose;” and

**WHEREAS** on the 30th September 2015, the Cabinet considered the acquisition of land described in the Schedule hereto for a public purpose; and

**WHEREAS** the House of Representatives and the Senate, by a Resolution dated 26th October, 2015 and 15th November, 2015 respectively, approved the acquisition of the land described in the Schedule for a public purpose;

**NOW, THEREFORE,** It is hereby **DECLARED** that the land described in the, Schedule hereto should be acquired for a public purpose.

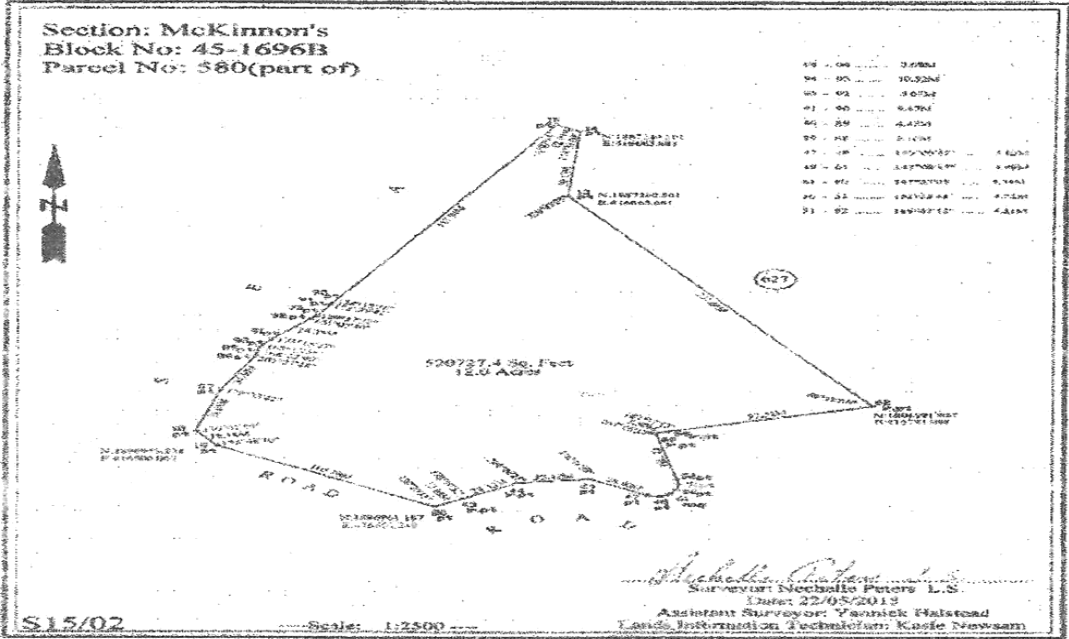
