Declaration dated the 7th day of August, 1997 made by the Secretary to the Cabinet under section 3 of the Land Acquisition Act Cap. 233 for the Acquisition of Guiana Island and the Lands described in the Schedule to this Declaration for a public purpose.

IT IS HEREBY DECLARED that the cabinet considers that the several pieces or parcels of land described in the Schedule hereto should be acquired for a public purpose namely for the promotion and development of tourism and supporting tourist related activities.
