DECLARATION dated the 30th day of May, 2023, made by the Secretary to the Cabinet under section 3 of the Land Acquisition Act Cap. 233 for the acquisition of the parcel of land in the Parish of St. John's and described in the Schedule hereto and in the Land Register for a public purpose.

IT IS HEREBY DECLARED that the Cabinet at its meeting held on the 10th May, 2023, considered that the parcel of land described in the Schedule hereto with building thereon be acquired for a public purpose, namely to prevent the closure of the Cancer Centre and to save lives of the patients currently receiving medical treatment at the Centre until such time that a buyer comes forward with an agreement and financial arrangement acceptable to the Government of Antigua and Barbuda or, in the alternative, the Government secures sufficient funding for the continued operation of the Cancer Centre.
