In exercise of the powers conferred pursuant to section 17 of the Supreme Court Order 1967, the Chief Justice and two other Judges of the Supreme Court make these Rules—

**1. Citation and Commencement**

(1) These Rules may be cited as the Eastern Caribbean Supreme Court (Sittings of the Court) (Amendment) Rules, 2017.

(2) These Rules shall come into effect on the 1st April, 2017.

**2. Interpretation**

In these Rules the “principal Rules” means the Eastern Caribbean Supreme Court (Sittings of the Court) Rules, 2014, S.I. No. 43 of 2014.

**3. Amendment of rule 4**

Rule 4 of the principal Rules is amended by deleting subrule (2) and substituting the following—

“(2) Subrule (1) shall not apply to Anguilla, Montserrat and the Nevis Circuit of Saint Christopher and Nevis.”.

**4. Amendment of rule 5**

Rule 5 of the principal Rules is amended by deleting –

(a) the heading and substituting the following –

**“Sittings of the High Court in Anguilla, Montserrat and Nevis”**

(b) subrule (1)(c) and (a) and substituting the following –

“(c) In Nevis on the first Tuesday of the months of April and November” .
