**The External Trade (Import Prohibition) Order 2001,
made by the Minister under section 3 of the External
Trade Act, Cap. 163.**

1. This Order is cited as the External Trade (Import Prohibition) Order, 2001. Short title.

2. (1) The import without a licence of goods from or originating in any country or place listed in the First Schedule is prohibited. Restriction of imports from certain countries S. 4, Cap. 163.

(2) Goods shall be deemed to have originated in a country if they are wholly produced or manufactured in that country.

3. (1) The import without a licence of goods listed in the Second Schedule is prohibited unless the goods are imported from a member country of the Organization of Eastern Caribbean States (OECS) or from the Caribbean Common Market (CARICOM). Restriction of import of certain goods.

(2) The import without a licence of goods listed in the Third Schedule is prohibited unless the country of origin is a member of the Organization of Eastern Caribbean States (OECS).

4. Nothing in this Order shall be construed as authorizing the import of goods, the entry of which is prohibited or restricted under any other law in force in Antigua and Barbuda. Order subject to other laws.

5. The External Trade (Import Prohibition) Order 1995 is revoked. Revocation S.I. 13 of 1995.

Goods from or originating in any country listed in the First Schedule is prohibited
