THE FREE TRADE AND PROCESSING ZONE (AMENDMENT OF SCHEDULE) REGU-LATIONS made in exercise of the powers contained in section 9 of the Free Trade and Processing Zone Act, 1994.

1. Short title

These Regulations may be citied as the Free Trade and Processing Zone (Amendment of Schedule) Regulations, 2012.

2. Repeal and substitution of Schedule

The Free Trade and Processing Zone Act 1994, No. 12 of 1994, is amended by repealing the Schedule and substituting the following—

"SCHEDULE"

Meeting of the Commission

(Section 9)

1. The Commission may meet at such times and at such places as the Chairman may determine.

2. All meeting shall be presided over by the Chairman, but where the Chairman is absent or for any reason unable to attend any meeting of the Commission, a person shall be elected from the member present and that person shall preside at the meeting and act as Chairman.

3. All the decisions of the Commission shall be by a majority of the votes of the members present and voting. In the case of a tie the chairman shall have a casting vote.

4. For the proper conduct of the business of the Commission, three members shall constitute a quorum.

5. The Commission shall appoint a fit and proper person to perform the duties of Secretary to the Commission.

6. The Secretary shall record the minutes of each meeting, and all the decisions of the Commission.
