Passport Act, Cap. 208.**

PREAMBLE

WHEREAS Antigua and Barbuda and other Participating Countries signed a Memorandum of Understanding on Immigration Arrangement for the ICC World Twenty 20, 2010 Championships, at Barbuda on 16th April, 2010; and

WHEREAS by Article 2 of the Memorandum of Understanding, the Participating Countries agreed that, during the period commencing on 10th April 2010 and ending on 24th May, 2010 they shall take the necessary executive or administrative action to permit multiple entries through their official posts of entry, of any person who is the holder of a NATIONAL VISA OR A CARICOM ENTRY PERMIT issued by any of the Participating Countries;

NOW, THEREFORE, IT IS Order as follows:

1. Short title

The Order may be cited as the Immigration and Passport (Visa Exemption) (ICC World Twenty 20, 2010 Championships) Order, 2010.

2. Interpretation

“Hob or Host Country” means Antigua ad Barbuda, Barbados, Guyana, St. Kitts and Nevis, St. Lucia and Trinidad and Tobago;

“Participating Countries” means those Hob or Host countries which have signed the Memorandum of Understanding on Immigration Arrangements for the ICC World Twenty 20, 2010 Championships.

3. Visa Exemption

Any person, who is the holder of a NATIONAL VISA or a CARICOM ENTRY PERMIT issued by any Participating Country, landing in Antigua and Barbuda from any place outside Antigua and Barbuda, is exempt from the provision of section 15 (1) of the Immigration and passport Act, Cap. 208, which requires that the passports of aliens and certain specified non-alins be visaed by a consular agent or consular officer in the service of the Government of Antigua and Barbuda or other person duly authorised before such persons land in Antigua and Barbuda.

4. Commencement

This Order is deemed to have come into force on 10th April, 2010 and ceases to have effect on 24th May, 2010 or at any later date that may be determined by the Minister.
