#### ANTIGUA AND BARBUDA

#### STATUTORY INSTRUMENTS

#### 2003, No. 10

The Immigration and Passport (Amendment) Regulations, 2003 made by the Minister under section 38 of the Immigration and Passport Act, Cap. 208.

1. These Regulations may be cited as the Immigration and Passport (Amendment) Regulations, 2003.

Short title.

2. The Immigration and Passport Regulations, in these regulations referred to as "the principal Regulations", are amended by the insertion immediately after Regulation 10, of the following Regulations —

Insertion of Registers 10A, 10B and 10C Cap. 208.

Form of application for, and certificate of, permanent residence.

- 10A. (1) An application for a permanent residence certificate shall be in the Form G1 in Schedule A.
- (2) A permanent residence certificate issued to an applicant shall be in the Form G2 in Schedule A.

Form of application for, and certificate of, temporary residence certificate Forms G1 and G2.

- 10B. (1) An application for a temporary residence certificate shall be in the Form G3 in Schedule A.
- (2) A temporary residence certificate issued to an applicant under section 17C(2) of the Act shall be in the Form G4 in Schedule A.

Form of application for renewal of temporary residence certificate.

- 10C. An application for the renewal of a temporary residence certificate shall be in the Form G5 in Schedule A."
- 3. The principal Regulations are amended by the insertion of the following Regulation immediately after Regulation 29 —

Insertion of Regulation 29A.

"Fees relating to permanent and temporary residence certificates. 29A. The fees specified in Schedule C shall be payable in respect of the matters set out in that Schedule."
