By the authority vested in me the Honourable Bertrand Joseph, as Minister of Sports, under section 3(1) (a) of the ICC Cricket World Cup West Indies 2007, Act 2006 ("the Act") I hereby declare the SIR VIVIAN RICHARDS CRICKET GROUNDS comprising ALL THAT parcel of land in the above mentioned title together with the Sir Vivian Richards Cricket Stadium thereon situate at North Sound in the Parish of Saint Peter, Antigua the same being delineated on the plan annexed hereto marked "A" signed by the Chief Surveyor EXCEPT for that parcel of land with building thereon known as the Abattoir as a CWC 2007 Venue with effect from the 12th day of March, 2007 to the 8th day of May, 2007.

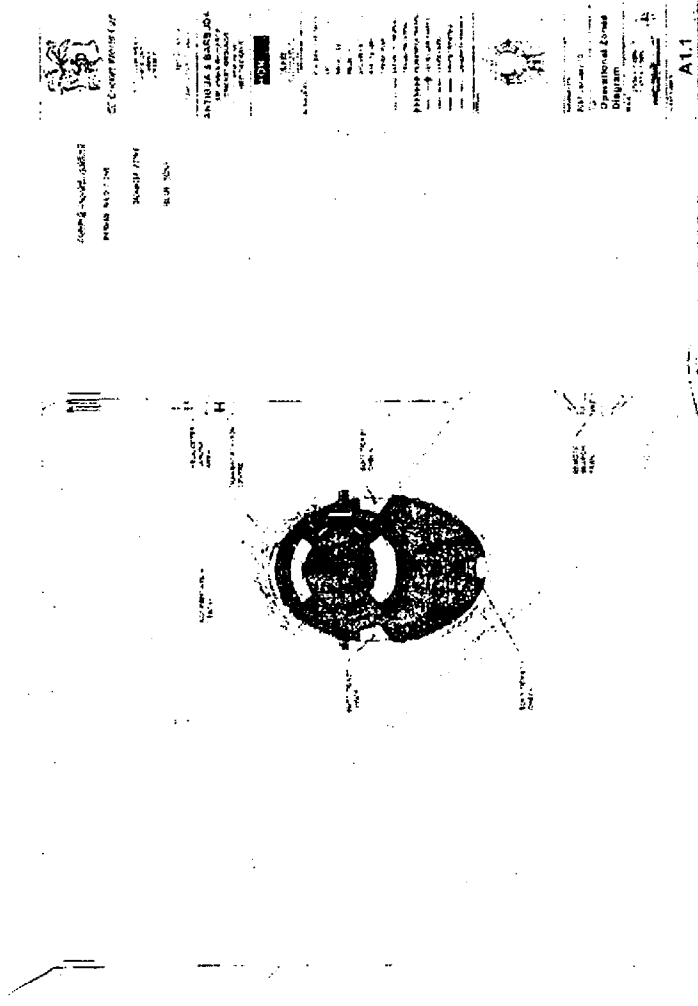
Further, by the authority vested in me pursuant to section 3(1) (b) of the Act, I declare the period 27th March, 2007 to 9th April, 2007 as a match period.
