**THE NON-CITIZENS LAND HOLDING REGULATION (THE GOVERNMENT OF THE
BOLIVARIAN REPUBLIC OF VENEZUELA) (EXEMPTION) ORDER 2019, made by a
Minister pursuant to Section 23 (1)(b) of the Non-citizens Land Holding Regulation Act,
Cap. 293, as amended.**

1. Citation

This Order may be cited as the Non-citizens Land Holding Regulation (The Government of the Bolivarian Republic of Venezuela) (Exemption) Order, 2019.

2. Exemption of the Government of the Bolivarian Republic of Venezuela

(1) The Cabinet by a decision made on the 3rd day of July, 2019 hereby exempts the Government of the Bolivarian Republic of Venezuela from the requirements of the Non-Citizens Land Holding Regulation Act, Cap. 293, as amended in respect of the transfer of the parcel of land outlined in the Schedule from the National Housing Development and Urban Renewal Company.

(2) The exemption granted under subsection (1) is without limitation and includes the requirement to hold a licence in respect of the land described in the schedule, the payment of stamp duty and any other fees and taxes related to the transfer of the land from National Housing Development and Urban Renewal Company Limited to the Government of the Bolivarian Republic of Venezuela.
