**Price Control (Non-Alcoholic Beverages) Order, made by
the Minister under section 3 of the Distribution and
Prices of Goods Act, Cap. 138.**

1. This Order may be cited as the Price Control (Non-Alcoholic Beverages) Order, 2001.

Short title.
2. The prices quoted in the third column of the Schedule are the fixed and declared maximum wholesale prices for the corresponding commodity in column 1 of the Schedule that may be sold by wholesalers throughout Antigua and Barbuda.

Maximum wholesale prices for non-alcoholic beverages.
3. The prices quoted in the fourth column of the Schedule are the maximum retail prices for which the specified size of a bottle of un-chilled non-alcoholic beverage listed in the first and second columns of the schedule may be sold by retailers throughout Antigua and Barbuda.

Maximum retail prices of un-chilled beverages.
4. The prices quoted in the third and fourth columns in the Schedule do not include the deposit of 30 cents per bottle. There is no deposit on a 250 ml/8oz. bottle coke.

Price exclude deposits.
5. (1) No person shall sell any non-alcoholic beverage at prices greater than the maximum prices fixed and declared in the Schedule.

Offence and penalty.

(2) Any person who contravenes sub-paragraph 1 commits an offence and is liable on summary conviction to a fine not exceeding five thousand dollars or to a term of imprisonment not exceeding three months.
6. This Order applies only to non-alcoholic beverages produced and bottled in Antigua and Barbuda.

Application of Order.
7. The Price Control (Non-Alcoholic Beverages) Order is revoked.
