WHEREAS it is provided in section 18(1) of the Representation of the People Act, Cap. 379, as amended, that the Governor-General shall, by Proclamation, specify a period within which a person who is qualified under section 16, may apply in accordance with the Registration Regulations, to be registered as an elector in the constituency in which he qualifies to be so registered; and

WHEREAS the Governor-General considers it expedient that a Proclamation be issued in accordance with section 18 of (1) of the Representation of the People Act, Cap. 379 as amended;

NOW, THEREFORE, I, DAME LOUISE AGNETHA LAKE-TACK, Grand Cross of the Most Distinguished Order of Saint Michael and Saint George, Governor-General of Antigua and Barbuda, hereby by this Proclamation, specify the period commencing on 23rd day of September, 2013 and ending on 25th day of October, 2013 as the period within which a person who is qualified under section 16 of the Representation of the People Act may be registered as an elector in the constituency in which he qualifies to be so registered.
