WHEREAS it is provided in section 18(1) of the Representation of the People Act, Cap. 379, as amended, that the Governor-General shall, by Proclamation, specify a period within which a person who is qualified under section 16, may apply in accordance with the Registration Regulations, to be registered as an elector in the constituency in which he qualifies to be so registered; and

WHEREAS by a Proclamation dated the 27th day of September, 2013 the Governor-General specified the period commencing on the 30th September, 2013 and ending on the 25th October, 2013 as the a period within which a person who is qualified under section 16 of the Representation of the People Act, may be registered as an elector in the constituency in which he qualified to be so registered; and

WHEREAS the Commission considers it desirable to extend the period specified by the Governor-General in the Proclamation dated the 27th September, 2013 for a further period of five days;

NOW, THEREFORE, I, DAME LOUISE AGNETHA LAKE-TACK, Grand Cross of the Most Distinguished Order of Saint Michael and Saint George, Governor-General of Antigua and Barbuda, acting on the advice of the Commission, hereby by this Proclamation, extend the period specified in the Proclamation dated the 27th day of September, 2013 for a further period of five days, commencing on the 28th day of October, 2013 and ending on the 4th day of November, 2013.
