Proceeds of Crime (External Forfeiture) (Canada) Order, made by the Attorney General under section 67 (1) of the Proceeds of Crime Act 1993 No. 13 of 1993.

1. This Order may be cited as Proceeds of Crime (External Short title. Forfeiture) (Canada) Order, 2000.

2. The Attorney General hereby orders that section 67 of the Proceeds of Crime Act 1993 No. 13 of 1993 shall apply to the Forfeiture Orders made by the Ontario Court of Justice, East Region on 23rd day of December 1999 in pursuance of the following matter:

Application of section 67 of Act No. 13 of 1993.

IN THE MATTER OF THE INVESTIGATION INTO CERTAIN OFFENCES UNDER SECTION 465 (1) (C) OF THE CRIMINAL CODE AND SECTION 5 (1) OF THE CONTROLLED DRUGS AND SUBSTANCES ACT

AND

IN THE MATTER OF AN APPLICATION BY THE ATTORNEY GENERAL OF CANADA UNDER SECTION 462.37 OF THE CRIMINAL CODE FOR AN ORDER OF FORFEITURE OF PROPERTY THAT IS PROCEEDS OF CRIME TO HER MAJESTY THE QUEEN IN THE RIGHT OF CANADA

BETWEEN

THE ATTORNEY GENERAL OF CANADA

and

SEAN CHARLES CALLEN, KERI-LYNN (nee NEWHOOK)

and

VILLA CAPRA ESTATES LIMITED Co. Respondents

Description of Properties.

3. The Forfeiture Orders referred to in paragraph 2 are in respect of the properties described in the Schedule and declared by the Ontario Court of Justice to be proceeds of crime and forfeited to Her Majesty the Queen in the Right of Canada.

Disposal of Properties.

4. The Forfeiture Orders further directed the forfeited properties to be disposed of by the Attorney General of Canada or dealt with in accordance with the law.
