THE PREVENTION OF TERRORISM (SECURITY COUNCIL RESOLUTION) (AMENDMENT) (NO. 23) ORDER, made in exercise of the powers contained in section 4 of the Prevention of Terrorism Act 2005, No. 12 of 2005 which authorizes the Minister of Foreign Affairs to make such provision as may appear to him to be necessary or expedient to enable the measures of the United Nations Security Council 1267 Sanctions Committee to be effectively applied in Antigua and Barbuda.

#### 1. Short title

This Order may be cited as the Prevention of Terrorism (Security Council Resolution) (Amendment) (No. 23) Order, 2011.

#### 2. Commencement

The Order shall be deemed to have come into operation on the 5th day of December, 2011.

#### 3. Amendment of Schedule

The Schedule is amended by revoking the entity designated as **QI.A.220.ot. Name:** 1: ABU SUFIAN 2: AL-SALAMABI 3: MUHAMMED AHMED 4: ABD AL-RAZZIO

And by making changes to the entity designated as **QI.A.283.10. Name:** 1: ANWAR 2: NASSER 3: ABDULLA 4L AL-AULAQI.

On 30 November 2011, the Security Council Committee pursuant to resolutions 1267 (1999) and 1989 (2011) amended the entry specified below to its Al-Qaida Sanctions List of individuals and entities subject to the assets freeze, travel ban and arms embargo set out in paragraph 1 of Security Council resolution 1989 (2011) adopted under Chapter VII of the Charter of the United Nations:
