PROPERTY FREEZING) (NO. 3) ORDER made in exercise of the powers contained in  
section 3(2) of the Prevention of Terrorism Act, 2005 No. 12 of 2005.**

**1. Short title**

This Order may be cited as the Prevention of Terrorism (Specified Entities Account and Property Freezing) (No. 3) Order, 2011.

**2. Interpretation**

In this Order the principal Act means the Prevention of Terrorism Act, 2005 No. 12 of 2005.

**3. Declaration of specified entity**

The entity listed in the Schedule is, declared, to be a specified entity in accordance with section 3 of the principal Act.

**4. Direction to financial institutions**

A financial institution in Antigua and Barbuda shall immediately restrain or freeze any account or other property held by the financial institution on behalf of the specified entity listed in the Schedule.
