THE PREVENTION OF TERRORISM (SPECIFIED ENTITIES ACCOUNT AND PROPERTY FREEZING) ORDER made in exercise of the powers contained in section 3(2) (b) of the Prevention of Terrorism Act, 2005 No. 12 of 2005.

1. Short title

This Order may be cited as the Prevention of Terrorism (Specified Entities Account and Property Freezing) Order, 2011.

2. Interpretation

In this Order the principal Act Means the Prevention of Terrorism Act, 2005 No. 12 of 2005.

3. Declaration of specified entity

The entities listed in the Schedule are, pursuant to the Prevention of Terrorism (Security Council Resolution) Orders, S.I. No's. 9 and 11 of 2011, deemed under section 4(2) of the principal Act, to be specified entities in accordance with section 3 of the principal Act.

4. Direction to financial institutions

A financial institution in Antigua and Barbuda shall immediately restrain or freeze any account or other property held by the financial institution on behalf of any of the specified entities listed in the Schedule.

SCHEDULE

On 8 February 2011, the Security Council Al-Qaida and Taliban Sanctions Committee approved the addition of the two entries specified below to its Consolidated List of individuals and entities subject to the assets freeze, travel ban and arms embargo set out in paragraph 1 of Security Council resolution 1904 (2009) adopted under Chapter VII of the Charter of the United Nations.
