STATUTORY INSTRUMENTS

1995, No. 37

Resolution providing for the continuance of the Emergency Orders made by the Cabinet in accordance with section 3 (1) of the Emergency Powers, (Hurricane, Earthquake, Fire or Flood) Act Cap. 307.

WHEREAS by Section 3 (1) of the Emergency Powers (Hurricane, Earthquake, Fire or Flood) Act Cap. 307, it shall be lawful insofar as the Proclamation declaring a state of emergency continues in force, for the Cabinet to make orders securing the essentials of life to the community and for the preservation of the health, welfare and safety of the public;

AND WHEREAS on the 5th day of September, 1995, the Cabinet issued a Proclamation declaring a state of emergency and that Proclamation continues in force;

AND WHEREAS in accordance with the Proclamation made on the 5th day of September, 1995 the Cabinet made certain orders, namely the Emergency Powers (Requisition of Transport) Order 1995 (1995, No. 32), the Emergency Powers (Fixing Maximum Retail Prices) Order 1995 (1995, No. 33), the Emergency Powers (Imposition of Curfew) (City of St. John's) Order 1995 (1995, No. 34) and the Emergency Powers (Fixing Maximum Retail Prices) (Amendment) Order, 1995 (1995, No. 35);

AND WHEREAS by Section 3 (3) of the Emergency Powers Act Cap. 307, any order so made shall be laid before the Legislature as soon as may be after it has been made, and shall not continue in force after the expiration of seven days from the time it is so laid unless a resolution is passed by the Legislature providing for the continuance thereof;

NOW, THEREFORE, Be It Resolved that this Honourable House approves the following Orders –

- (a) the Emergency Powers (Requisition of Transport) Order 1995 (1995, No. 32);
- (b) the Emergency Powers (Fixing Maximum Retail Prices) Order 1995 (1995, No. 33),
- (c) the Emergency Powers (Imposition of Curfew) (City of St. John's) Order 1995 (1995, No. 34) and

- (d) the Emergency Powers (Fixing Maximum Retail Prices) (Amendment) Order, 1995 (1995, No. 35).

AND BE IT FURTHER RESOLVED by this Honourable House that —

- (a) the Emergency Powers (Fixing Maximum Retail Prices) Order 1995 (1995, No. 33);
- (b) the Emergency Powers (Imposition of Curfew) (City of St. John's) Order 1995 (1995, No. 34)
- (c) the Emergency Powers (Fixing Maximum Retail Prices) (Amendment) Order, 1995 (1995, No. 35)

Be continued in force until the 4th day of October, 1995.
