THE REVENUE RECOVERY CHARGE (EXEMPTION) (NO. 5) ORDER, made in exercise of the powers contained in section 11(2) of the Revenue Recovery Charge Act, 2010, No. 8 of 2010.

1. Short title

This Order may be cited as the Revenue Recovery Charge (Exemption) (No.5) Order, 2011.

2. Exemption

The Minister of Finance, in exercise of the powers contianed in Section 11(2) of the Revenue Recovery Charge Act, 2010, has exempted mas troupes, mas groups, steel bands, bands and musicians, who are duly registered with the Ministry of Tourism, Civil aviation and Culture, in respect of importation of the following materials and promotional items and paraphernalia to be used in the preparation for and during Antigua's 55th Carnival Celebrations 2011—

- (i) All raw materials to include beads, sequins, cloth, leatherette, pellon, glue, staple guns, staples, body suits, accessories, t-shirts, shoes, leotards, stockings, paints and paint brushes, promotional items, and other materials needed which are in line with the concessions;
- (ii) Steel pans, cases, stands, sticks, oil drum, percussion instrumental, metal sheeting for trolleys and wheels, drum sets, and hardware to include skins, components to construct trolleys, wheels and accessories for trolleys;
- (iii) Speakers, keyboards, drum set, guitars, microphone, microphone stand, cable cords amplifier, and other electronic instrument needed which are in line with these concessions;
- (iv) Compact disc or any type of music produced by local artists, calypsonians and bands;
- (v) Streamers, water bottles, vests, polo shirts, whistles, strings, disposable cameras, bandanas, wristbands, flags, bags, posters, flyers, mugs, cups, purses, key rings, pens, pencils, and souvenirs;
- (vi) All floats materials to include floral sheeting an fringes, sequin sheeting, feathers and accessories, body suits and costume materials, blow-up balloons, festoons,
