THE STAMP ACT (STAMP DUTY EXEMPTION) (AIRPORT AUTHORITY) ORDER made by the Cabinet under section 9(2) of the stamp Act, Cap. 410, as amended by section 4 of the Law Revision (Miscellaneous) (Amendments) Act, 1998, No. 1 of 1998.

1. Short Title.

This Order may be cited as the Stamp Act (Airport Authority Stamp Duty Exemption) Order, 2009.

2. Exemption from Payment of Stamp Duty

The names of the persons appearing in the Schedule are exempted from the payment of stamp duty on the purchase and transfer of the parcels of land described in the Schedule to the extent specified in the second column.
