THE STAMP ACT (STAMP DUTY EXEMPTION) (SEVENTH-DAY ADVENTIST RADIO BOARD OF TRUSTEES/MRS. MAPLE LAKE) ORDER made by the Cabinet under section 9(2) of the stamp Act, Cap. 410, as amended by section 4 of the Law Revision (Miscellaneous) (Amendments) Act, 1998, No. 1 of 1998.

1. Short Title.

This Order may be cited as the Stamp Act (Exemption from Payment of Stamp Duty) Order, 2009.

2. Exemption from Payment of Stamp Duty

The names of the persons appearing in the Schedule are exempted from the payment of stamp duty on the transfer of shares described below to the extent specified in the second column.

Schedule

Name	Extent of Exemption
Board of Trustees of the Seventh-Day Adventist Radio (purchaser).	Waiver in whole of stamp duty payable by the Board of trustees of the Seventh-Day Adventist Radio the (purchaser) on the purchase and transfer of all the shares held by Mrs. Maple Lake in the Second Advent Radio Ministry Ltd.
Mrs. Maple Lake Transferor (vendor).	Waiver in whole of stamp duty payable by Mrs. Maple Lake (vendor) on the sale and transfer of all the shares held by her in Second Advent Radio Ministry Ltd.
