#### 1. Short title

This order may be cited as the Stamp Act (Exemption from payment of Stamp Duty) (Antigua Insurance Company LTD) Order, 2013.

### 2. Exemption from payment of Stamp Duty.

The names of the persons appearing in the first column of the Schedule are exempted from the payment of stamp duty on the sale and transfer of the parcels of the land described in the Schedule to the extent specified in the second column.
