The Stamp Act (Exemption of Duty) Order made by the Cabinet under section 9(2) of the Stamp Act Cap. 410 as amended by section 4 of the Law Revision (Miscellaneous Amendments Act) 1998 (No. 1 of 1998.)

- 1. This Order may be cited as the Stamp Act (Exemption of Short title. Duty) Order, 2005.
- 2. Non-Such Development Company Ltd. as the Purchaser and the companies appearing in the first colum of the Schedule as the Vendors of the parcels of land specified in the third colum of the Schedule are exempted from payment of stamp duty on registration of transfer instruments in respect of the parcels of land described in the Schedule.
