In exercise of the powers conferred by section II of the Supreme Court Order Cap 422A, Revised Laws of Antigua & Barbuda, 1992, as amended, and with the concurrence of the Prime Ministers and the Premiers of all the States, the Judicial and Legal Services Commission makes this Order:

### 1. Short title

This Order may be cited as the Supreme Court (Salaries, Allowances and Conditions of Service of Judges) (Amendment) Order 2008, and shall be read as one with the Supreme Court (Salaries, Allowances and Conditions of Service of Judges) Order 1996 as amended (hereinafter referred to as the "principal Order").

### 2. Commencement

This Order shall be deemed to have come into operation on the 1st day of July, 2008.

### 3. Amendment of section 7

Section 7 of the principal Order is hereby amended as follows:

- (1) by deleting the figures \$60 and \$50 appearing in the second line of subsection (2) thereof and by substituting therefor the figures \$150 and \$100 respectively;
- (2) by deleting the figure \$50 appearing in the third line of subsection (3) thereof and by substituting therefor the figure \$100.

## 4. Replacement of section 8 of the principal Order

Section 8 of the principal Order is hereby revoked and replaced as follows:

**\*\*8. Entertainment Allowance.** The Chief Justice shall be entitled to be paid an entertainment allowance at the rate of \$15,000 per annum, the Justices of Appeal at the rate of \$12,000 per annum and the Puisne Judges at the rate of \$9,000 per annum."
