SCHEDULE

1. Short title

This Order may be cited as the Stamp (Antigua and Barbuda) (U.N. Holocaust Remembrance) Order, 2007.

2 Special Stamps

Special Stamps of the value and description specified in the Schedule are authorized for sale in Antigua and Barbuda.

3. Duration

The Special Stamps authorized by this Order shall remain on sale for a period of three (3) months until 24th January, 2008, or until stocks are exhausted, which ever is earlier.

4. Commencement

This Order comes into force on 25th October, 2007.
