THE VEHICLE AND ROAD TRAFFIC (MOBILE DEVICES) REGULATIONS made in exercise of the powers contained in section 87 of the Vehicles and Road Traffic Act, Cap. 460.

#### 1. Short Title

These Regulations may be cited as the Vehicle and Road Traffic (Mobile Devices) Regulations, 2019.

#### 2. Commencement

These Regulations shall come into effect the 1st day of February, 2019

## 3. Interpretation

(1)In the Regulations—

"interactive communications function" includes-

- (a) sending or receiving oral or written messages;
- (t) sending or receiving facsimile;
- (c) sending or receiving still or moving images;
- (a) providing access to the internet;

"mobile device" means a mobile telephone or any other device, other than a two-way radio, which performs an interactive communication function by transmitting and receiving data;

"two-way radio" means any wireless telecommunications appararus which is designed or adapted-

- (a) for the purpose of transmitting and receiving messages; and
- (*t*) to operate on any frequency other than 880 MHz to 915 MHz, 925 MHz to 960 MHz, 1710 MHz to 1785 MHz to 1880 MHz, 1900 MHz to 1980 MHz or 2110 MHz to 2170 MHz:

"wireless communication device" means a device used to transfer information over a distance without the use of electronic conductors or wire.
