Vehicles and Road Traffic (Amendment) Regulations, 2000 made by Cabinet under section 87 of the Vehicles and Road Traffic Act, Cap. 460.

1. These Regulations may be cited as the Vehicles and Road Short title. Traffic (Amendment) Regulations, 2000.

2. Regulation 4 of the Vehicles and Road Traffic Regulations (in these Regulations referred to as the "principal Regulations") is repealed and the following substituted:

Amendment of regulation 4 of the Vehicle and Road Traffic Regulations.

"Registration number plate "

4. (1) In accordance with the Bicycle Order a pedal bicycle shall carry a registration number plate which must conform to the size, lettering and numbering as set out in the Schedule to the Transport Board Regulations.

- (2) All applications for registration of a pedal bicycle shall be made to the Licensing Officer in the form set out in Form 1A of the Schedule.
- 3. Regulation 5 of the principal Regulations is repealed and the following substituted:

Amendment of regulation 5.

"Position of registration number plate.

- 5. (1) The registration number plate to be carried by a pedal bicycle shall have duplicate faces conforming with the Schedule to the Transport Board Regulations and shall be fixed on the front mudguard of the pedal bicycle, in a vertical position so that from whichever side the pedal bicycle is viewed the letters and figures on one of the faces of the plate are easily distinguishable though they may not be distinguishable from the front of the pedal bicycle.
- (2) The Licensing Officer may direct the position in which the registration number plate shall be fixed if he is not satisfied with

the position in which it has been fixed on the bicycle.

Amendment of regulation 6,

4. Regulation 6 of the principal Regulations is repealed and the following is substituted:

"Registration number plate to be legible. 6. The registration number plate on a pedal bicycle shall at all times be legible and shall not be obstructed by any other figures, designs or ornamentation.".

Amendment of regulation 7

- 5. Regulation 7 of the principal Regulations is amended by
 - (a) repealing "IDENTIFICATION MARK" in the marginal note and substituting the following:

"REGISTRATION NUMBER PLATE"; and

(b) repealing "identification plate" and substituting the following:

"registration number plate".

Amendment of regulation 10.

- 6. Regulation 10 of the principal Regulations is amended
 - (a) by repealing "First Schedule" wherever it occurs and substituting "Schedule";
 - (b) in sub-regulation (1) by repealing the words from "together" to "(Form 3C)" at the end of the subsection and substituting the following:

"which the applicant shall present to the Transport Board for a sticker to be affixed to the vehicle so licensed."; and

- (c) in sub-regulation (2) by
 - (i) repealing "circular disc" and substituting the following:

"sticker"; and

(ii) repealing "the licensee" and substituting the following:

"a person designated by the Transport Board".

7. Regulation 17 of the principal Regulations is amended as Amendment of follows:

regulation 17.

(a) in sub-regulation (1) by repealing:

> "Every motor vehicle shall be equipped with at least two lamps at the front of the vehicle, one on each side.";

(b) in sub-regulation (3) by repealing "identification plate" and substituting the following:

"registration number plate";

- by repealing sub-regulation (4).
- 8. Regulation 19 of the principal Regulations is amended in Amendment of sub-regulation (4) by repealing "Examining Officer" and sub-regulation19. stituting the following:

"Vehicle Examiner".

- (2) The Second Schedule to the principal Regulations is repealed.
- (3) The Vehicles and Road Traffic (Control of Hire) Regu- Cap. 286. lations is repealed.
