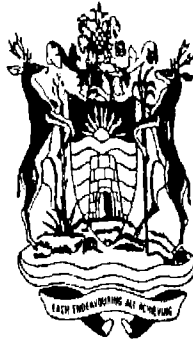

THE VEHICLES AND ROAD TRAFFIC (ONE WAY TRAFFIC) (ST. JOHN'S)
(AMENDMENT) REGULATIONS made in exercise of the powers contained in section 87 of the
Vehicles and Road Traffic Act Cap. 460.

1. Short title

These Regulations may be cited as the *Vehicles and Road Traffic (One Way Traffic) (St. John's)*
(Amendment) Regulations, 2009.

2. Amendment of Regulation 3-Offences

Regulation 3 is amended by repealing the words "five hundred dollars" and substituting the words
"fifteen hundred dollars".

3. Amendment of the Schedule

The Schedule is amended as follows—

(a) In Heading A, by inserting after paragraph 4 of the following—

"(5) Nellie Robinson Street between All Saints Road and Independence Drive".

(b) In Heading A, by inserting after paragraph 4 the following—

"(6) Lionel Hurst Street between All Saints Road and Independence Drive.

(7) That unnamed Street north of the Old Parham Road which runs parallel to Old Parham Road
between Wireless Road and that unnamed street which runs north to south to Old Parham Road
and alongside Stanley Mathew's Auto Body Repair Shop".

(c) In Heading B, by inserting after paragraph 5 the following—

"(6) Andy Roberts Street between Independence Drive and Temple Street.

(7) Prince Klaas Street between Independence Drive and All Saints Road.

(8) Nelson Street between Independence Drive and All Saints Road.

(9) That part of Tanner Street between Market Street and the private car park situated in close proximity to Redcliffe Quay”.

(d) In Heading C, by repealing in paragraph 5 the words “from New Street to High Street” and substituting the words “between Vivian Richards Street to Long Street”.

(e) In Heading C, by inserting after paragraph 6 the following —

“(7) Church Lane between Long Street and Newgate Street.

(8) Gutter Lane between Long Street and Newgate Street.

(9) Agatha Goodwin Street from the junction of St. John's Street and Newgate Street.”

(f) In Heading D, by repealing in paragraph 3 the words “New Street” and substituting the words “Vivian Richards Street”.
