**BERMUDA HOUSING (VESTING OF LAND) (No. 2) ORDER 1984**

**Citation**

1 This Order may be cited as the Bermuda Housing (Vesting of Land) (No. 2) Order 1984.

**Vesting of twenty parcels of land**

2 The twenty parcels of land described in the Schedule hereto and listed by the Parish in which the land is situated, being lands the property of the Crown, are hereby vested absolutely in the Bermuda Housing Corporation.
