Form of notarial seal

- 1 The form of seal to be used for the purposes of section 9 of the Commissioners for Oaths and Notaries Public Act 1972 [title 8 item 22] shall be as follows—
 - (a) the seal shall be not less than 1 ½ inches in diameter;
 - (b) in the middle of the seal there shall be the words "NOTARY PUBLIC";
 - (c) around the edge of the seal shall be the name of the notary public and the word "BERMUDA".

Enrolment of a notary public

2 A fee of \$200 shall be paid upon the enrolment of a notary public.
