The Regulatory Authority, in exercise of the power conferred by section 62 of the Regulatory Authority Act 2011 and section 26 of the Electronic Communications Act 2011, makes of the following General Determination:

Citation

1 This General Determination, the terms and conditions of which are contained in the Schedule, may be cited as the Regulatory Authority (Electronic Communications Price Comparison Website) General Determination 2015.

Interpretation

In this General Determination, unless the context otherwise requires, terms shall have the meaning given in the Regulatory Authority Act 2011 ("the RAA"), the Electronic Communications Act 2011 ("the ECA"), and the Schedule.

General purpose

3 This General Determination provides for the establishment and implementation of an Electronic Communications Price Comparison Website.

Determination

- 4 (1) This General Determination is made pursuant to the Consultation entitled "Telecommunications Price Comparison Website TeleCheck.bm" (Matter PPC 1798/2014), and the Regulatory Authority's decision on it.
- (2) Taking into account the responses received to the Consultation and for the reasons given in the decision, the Regulatory Authority ("the RA") determines that—
 - (a) the establishment and implementation of an Electronic Communications Price Comparison Website is in the public interest and would greatly benefit consumers of residential Electronic Communications Services; and
 - (b) all Relevant Electronic Communications Service Providers ("RECSPs") shall—
 - (i) comply with all deadlines that the RA may from time to time impose on RECSPs with respect to the establishment and implementation of the Electronic Communications Price Comparison Website;
 - (ii) participate in the Electronic Communications Price Comparison Website training and testing sessions according to the timetable to be established by the RA;
 - (iii) post all Tariff Information to the Electronic Communications Price Comparison Website by the dates established by the RA; and
 - (iv) ensure that the Tariff Information posted to the Electronic Communications Price Comparison Website is kept accurate and up to date.

Terms and conditions of General Determination

- 5 (1) The Schedule to this General Determination has effect.
- (2) The Schedule is published on the RA's website (www.rab.bm), and is also available for inspection at the offices of the RA (Cumberland House, 1 Victoria Street, Hamilton) during ordinary business hours.

Effective Date of General Determination

6 This General Determination shall become effective on the day it is published in the Official Gazette.
