[made under section 33 of the Real Estate Agents' Licensing Act 1976 [title 30 item 20] and brought into operation on 1 December 1977]

Form of licence

#### Interpretation

- 1 In these Regulations unless the context otherwise requires—
  - "the Act" means the Real Estate Agents' Licensing Act 1976 [*title* 30 item 20];
  - "Form" means the appropriate Form prescribed in the Schedule to these Regulations.

## **Application for licence**

2 (1) An application for the grant of a licence as an agent shall be made to the Superintendent in Form 1.

(2) An application for the grant of a licence as a salesman shall be made to the Superintendent in Form 2.

by—

- (3) Applications under this regulation shall be accompanied
  - (a) the fee prescribed under the Government Fees Regulations 1976 [title 15 item 18(a)] for issuing an annual agent's licence or an annual salesman's licence, as the case may be; and
  - (b) such proof as the Superintendent may require that the applicant, or, if the applicant is a partnership or company, that its representative—
    - (i) is over the age of 18; and
    - (ii) is Bermudian, or has permission from the Minister responsible for Immigration to work in Bermuda as a real estate agent, or salesman, as the case may be; and
    - (iii) is of good character.

#### Form of licence

3 An agent's licence shall be in Form 3, and a salesman's licence shall be in Form 4.

#### **Renewal of licence**

4 (1) A licence issued under regulation 2 shall lapse on the 30th day of September next after that licence is issued, unless on or before the 20th day of September next after that licence is issued the holder thereof applies for its renewal.

(2) An application for renewal of an agent's licence shall be in Form 6 accompanied by the fee prescribed in the Government Fees Regulations 1976 for issuing an annual agent's licence.

(3) An application for renewal of a salesman's licence shall be in Form 7 accompanied by the fee prescribed in the Government Fees Regulations 1976 [*title 15 item 18(a)*] for issuing an annual salesman's licence.

## Written examination

5 (1) Where an applicant for a licence as an agent has not been ordinarily engaged in full time practice as a real estate agent or salesman in Bermuda for a period of three years or more immediately preceding 1 December 1977, the Minister may require him to sit for and pass a written examination. (2) An examination under paragraph (1) shall be set, conducted and judged by an advisory board appointed by the Minister under section 8 of the Act.

- (3) The advisory Board shall set the examination so as to-
  - (a) test the applicant's knowledge of the Act; and
  - (b) discover if the applicant has the requisite knowledge and skill to practise as an agent in Bermuda.

## **Display of licence**

6 (1) A licensed agent shall exhibit his licence and keep it exhibited in a prominent place at the address shown thereon.

(2) A licensed salesman shall keep his licence at the office of the agent by whom he is employed, and shall, on being so requested by any person, produce his licence for inspection.

### Surrender of licence

7 (1) Where an agent's licence is revoked or suspended that agent shall immediately return his licence and the licence of each of his salesmen to the Superintendent.

(2) Where a salesman's licence is revoked or suspended the agent employing that salesman shall immediately return that salesman's licence to the Superintendent.

(3) Upon the termination of the employment of a salesman for any reason the agent employing him shall immediately return that salesman's licence to the Superintendent, together with a written statement of the circumstances of the termination.

## Change of employer

8 (1) When a salesman has transferred his employment from one agent to another agent it shall be the duty of both the salesman and the new agent employing him to advise the Superintendent in writing of that change not later than fourteen days thereafter.

(2) Where under paragraph (1) the Superintendent is duly notified of the transfer of a salesman from one agent to another agent, he shall issue that salesman with a new licence, unless that salesman has failed to carry out any of his duties under the Act or these Regulations.

## **Personal representative**

9 (1) Where an individual who carries on business as an agent dies, the Minister may grant to his executor or administrator temporary registration as an agent for a period of not more than six months in respect of the business of the deceased agent.

(2) Where temporary registration is granted under paragraph (1) all salesmen licensed as salesmen of that deceased agent at the time of his death shall be deemed to be licensed as salesmen of such executor or administrator.

### Form of auditor's report

10 A report by an agent's auditors under section 16(3) of the Act shall be in Form 5.
