WHEREAS it is expedient to amend the Motor Car Act 1951 to increase the permit fees and the licence duty payable in respect of different classes of vehicles;

Be it enacted by The Queen's Most Excellent Majesty, by and with the advice and consent of the Senate and the House of Assembly of Bermuda, and by the authority of the same, as follows:

Citation

1 This Act, which amends the Motor Car Act 1951 (the "principal Act"), may be cited as the Motor Car Amendment Act 2018.

Amends section 43

2 Section 43(2) of the principal Act is amended by inserting after paragraph (b) the following—

"(ba) an applicant for a permit shall, on the grant of the permit, pay the fee set out in Schedule 1C;"

MOTOR CAR AMENDMENT ACT 2018

Amends section 59

3 Section 59(1) of the principal Act is amended—

- (a) in paragraph (b) by deleting “\$100” and substituting “\$105”;
- (b) in the proviso after paragraph (b), by deleting “\$50” and substituting “\$52.50”.
