His Excellency the Governor, in exercise of the power conferred by section 3 of the Emergency Powers Act 1963, makes the following Regulations:

Citation

These Regulations, which amend the Emergency Powers (COVID-19 Continuing Precautions) Regulations 2020 ("the principal Regulations"), may be cited as the Emergency Powers (COVID-19 Continuing Precautions) Amendment (No. 6) Regulations 2020.

Amends regulation 5

2 In regulation 5(1) of the principal Regulations, delete paragraph (b).

Amends regulation 6

3 In regulation 6 of the principal Regulations, in paragraph (3) delete ", subject to the written permission of the Minister of Health."

Amends regulation 11A

4 In regulation 11A of the principal Regulations, delete paragraph (b).

Amends regulation 11B

- 5 In regulation 11B of the principal Regulations—
 - (a) in the heading, after "beauty salons" insert ", spas";
 - (b) in the opening words, after "beauty salon" insert ", spa";
 - (c) delete paragraph (b).

Amends regulation 12B

- $6\,$ In regulation 12B of the principal Regulations, delete paragraph (d) and substitute—
 - "(d) all of the conditions in regulation 11A (bars) in relation to the operation of any licensed bar on the premises of the club."

Amends regulation 13

- 7 In regulation 13(1)—
 - (a) in paragraph (cb), after "beauty salon" insert ", spa";
 - (b) delete paragraph (e) and substitute—
 - "(e) other business.".

Amends regulation 16

- $8\,$ In regulation 16 of the principal Regulations, delete paragraph (1) and substitute—
 - "(1) Subject to the size of the boat, and provided appropriate physical distancing can be and is maintained at all times, the maximum number of persons (including any crew) who may use a boat for recreational purposes is—
 - (a) 20; or
 - (b) in the case of a boat operated commercially for hire or reward, the number of passengers specified in the licence issued under the Marine Board (Island Boats) Regulations 1965."

Amends Schedule 2

- 9 In Schedule 2 to the principal Regulations—
 - (a) delete the heading, and substitute "SHOPPING DAYS FOR GROCERY STORES";
 - (b) revoke paragraph 1(3).
