**AN ACT FOR THE APPROPRIATION OF FURTHER DIVERS SUMS  
OF MONEY FOR AND TOWARDS DEFRAYING THE EXPENSES OF  
THE GOVERNMENT OF THE COMMONWEALTH OF THE  
BAHAMAS FOR CAPITAL DEVELOPMENT FOR THE FISCAL YEAR  
COMMENCING 1ST JULY 2019 AND ENDING 30TH JUNE 2020**

**[Date of Assent - 13<sup>th</sup> March, 2020]**

**Enacted by the Parliament of The Bahamas**

**1. Short title.**

This Act may be cited as the Supplementary Appropriation (2019/2020) (Capital Development Account Expenses) Act, 2020.

**2. Further expenditure charged on the Consolidated Fund of The Bahamas.**

The further sum of One Hundred Fifty Million Five Hundred Thousand Dollars (B\$150,500,00) shall be charged on the Consolidated Fund and other public funds of The Bahamas for the expenses set out in the *Schedule* for the period ending 30<sup>th</sup> June, 2020.

**3. Purpose of appropriation.**

The further sum charged under section 2 of this Act is hereby appropriated to the services and other expenses expressed in the said *Schedule* and shall be deemed to have been appropriated from the 1<sup>st</sup> July, 2019.
