

CHAPTER 277**BOAT REGISTRATION****BOAT REGISTRATION (OUT ISLAND PORT
AUTHORITIES) ORDER***S.I. 11/1970*

(SECTION 11(5))

[Commencement 28th February, 1970]

1. This Order may be cited as the Boat Registration (Out Island Port Authorities) Order. Title.

2. Each of the Out Island Port Authorities specified in the Schedule hereto is hereby empowered to grant or refuse any application for — Power to determine applications.

- (a) the registration of boats to be operated solely within the Port Area (or waters adjacent thereto) of the Port Authority; and
- (b) a licence to act as the master of any such boats, without forwarding the same to the New Providence Port Authority as required by section 11(3) of the Boat Registration Act. Ch. 277.

BOAT REGISTRATION RULES

(SECTION 21)

[Commencement 18th November, 1961]

- Short title. **1.** These Rules may be cited as the Boat Registration Rules.
- Interpretation. **2.** In these Rules, unless the context otherwise requires —
- “Act” means the Boat Registration Act;
- “boat” means every description of vessel used in navigation however propelled;
- “certificate” means a certificate of registration issued under the provisions of section 13 of the Act;
- “licence” means a licence issued under the provisions of section 13 of the Act;
- “New Providence Port Authority” means the Port Authority for New Providence appointed under the Port Authorities Act;
- “Out Island authority” means the port authority for an Out Island or district and, where there is no port authority, the commissioner of the district.
- Ch. 269. **3.** (1) Every owner desirous of operating a boat for hire shall apply for registration of that boat to the New Providence Port Authority or an Out Island authority as the case may be and shall furnish all relevant particulars and make any relevant declaration specified in Form I of the Schedule to these Rules.
- (2) Every person desirous of acting as master of a boat for hire shall apply to the New Providence Port Authority or an Out Island authority as the case may be and shall furnish all relevant particulars and make any relevant declaration specified in Form II of the Schedule to these Rules.
